As per Order 1<sup>st</sup> cited 1/3 Higher Grade of Health Supervisor was sanctioned to Sri.Abdul Saleem Manima (Sl.No.55 Rank No.180) is hereby cancelled since his name is seen mentioned in the seniority list in 2 different places and as per the seniority is not due for Higher Grade at present.

As per the Order 3<sup>rd</sup> cited 1/3 Higher Grade was sanctioned to the incumbents w.e.f 09/11/2012 from rank No.184 to 196. But the incumbents included in the said Order has claimed that they are eligible for Higher Grade w.e.f 1/4/2011, since some of the employees has retired on 31/3/2011 and hence the vacancies arised w.e.f 1/4/2011.
